The AKC Farm Dog Certified (FDC) Test is open to all dogs <u>at least 9 months of age</u> that are individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers, or neutered dogs enrolled in the AKC Canine Partners program. Females in season may not participate. Dogs with physical challenges (including amputees) are eligible to enter provided, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the entire course.

ENTRIES OPEN FOR BOTH TESTS ON FEBRUARY 1, 2024 Please do not send early entries; they will be refused.

## PRE-Entries Close FOR BOTH TESTS: THURSDAY, MARCH 14, 2024 With the last mail delivery from USPS to the LKC Post Office box (see entry form for complete address)

After this time. entries cannot be accepted, cancelled or substituted except as provided for in Chapter 14, Section 6 of the Dog Show Rules and Chapter 3, Section 1 of the Regulations for Herding Tests and Trials.

#### **ENTRY INFORMATION – FARM DOG TEST**

**ENTRY FEES: Pre-entries: \$35 /PER DOG/per RUN**, includes AKC \$3.50 recording fee. Make checks payable to <u>Lawrenceville Kennel Club</u>. Day of entries will be taken from 7:30 AM provided there is space available in either test. **Day of entry fee will be \$40/per dog/per run**; <u>cash only</u>. Please note it takes two test passes to earn the title, so cost is per test.

Confirmations and judging schedule will be sent by e-mail only.

Drawing for running order will be made at the trial secretary's address on Sunday, March 17 at Noon. All fees payable to **LKC** includes \$3.50 AKC recording fee per dog/per run If sending entries overnight, make sure to choose option that will allow delivery to the designed PO box of the entry address with a signature. Requiring a signature or express entries sent to any other address other than PO box will only delay receipt of your entries.

Returned Checks do not constitute a valid entry and will be subject to a \$35 collection fee. Owners are responsible for errors in making out entry forms and no entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Please type or print clearly & carefully the information on entry forms to eliminate errors. The Trial Secretary is not responsible for illegible (in the opinion of the Trial Sec) entry form information. LKC may decline entries and may remove any dog on any account of disease, viciousness or other cause, and no one shall have any claim against the aforementioned group or any official or member thereof. Entry fees will not be refunded in the event a dog is absent, not allowed to compete in the entered test, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the Trial Committee. If because of riots, civil disturbance or acts beyond the control of the management it is impossible to open or complete the Test, no refund will be made. When entry limits are reached, all additional entries received prior to closing will be added to an alternates list in the order entry was received. The alternates list will be used to fill vacancies that occur in the drawn running order, with the first alternate entry replacing the first vacancy in the event entered. A signed Consent and Release from Liability form must accompany each entry. Failure to do so will result in you and your dog being barred from entering the grounds and competing in these trials.

**PRIZES:** Each dog that passes a Farm Dog Certification Test will receive a dark green ribbon. Each dog that passes 2 Farm Dog Certification Tests from 2 different judges will receive a Lake Lanier Cluster New Title ribbon

Dogs that pass Farm Dog Certification Tests under two different judges are eligible for a Farm Dog Certified Title. An application form for the title is included in the premium list for the convenience of exhibitors. Owners will need to complete the application form and send it and the appropriate fee to the American Kennel Club; the LKC will not do this submission for exhibitors, **but will help Juniors with the form.** 

**DIRECTIONS TO SHOW SITE**: The site is the Gwinnett County Fairgrounds, 2405 Sugarloaf Pky, Lawrenceville, GA 30045. Use Davis Road entrance for daily vehicle entry. Parking fee is \$5 per day.

# EXHIBITOR INFORMATION: Handler Meeting – 8:00 AM

- Check in will begin at 7:30 AM for morning event and 12:30 PM for afternoon event
- Tests will begin at 8:30 AM for the morning event and 1 PM for the afternoon event.
- Dogs must wear a secure, well-fitting, <u>flat collar</u> during the test evaluation and be held on a proper fixed-length leash at all times while on the farm site unless confined in a crate, kennel or vehicle. The leash shall be four to six feet in length. No prong or electronic collars, head halters, harnesses or flexi-leads are permitted on the premises.
- <u>NO FLEXI-TYPE RETRACTABLE LEASHES ALLOWED</u> on site.
- You are responsible for picking up after your dogs and disposing of waste in the proper receptacles. A failure to do so could result in you and your dog being dismissed from the trial grounds and be barred from competing.
- Under no circumstances will dogs be allowed to disturb the resting herding stock nor to interfere outside the testing area with another dog's performance in the test areas. The Judge may request the removal of any dog from the immediate test area at any time, if they determine the presence of the dog presents a risk to livestock, other dogs or persons on the farm or the test site.
- Un-entered dogs are NOT allowed in the test/trial areas.
- Bitches in season may not enter.
- No dog may be entered in two tests on the same course with the same judge at any Test.
- Dogs must be ready for judging. Neither the Club nor the Course Director will be responsible or obligated to furnish any services for notifying exhibitors or their agents of judging time.
- The Groups sponsoring these events, the course director, their agents, officers, club members and committee members shall assume NO RESPONSIBILITY for injury to you, children or dogs. YOU ENTER AT YOUR OWN RISK.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Rabies vaccination is required of all animals.

FARM DOG CERTIFIED TEST 12 Elements

The Farm Dog Centified Test consists of 12 situations that a dog might encounter in a typical farm environment. All of the exercises are done on leash.

Test 1: Greet the judge The handler approaches the judge with the dag at their adds on a focus lead. The dag must not jump, or show appreasion or excessive shyness.

Text 2: Walk around the farm and a passive stranger The hundler walks the dog on a toose lead at least 200 feet around a variety of objects and near a ulting person

Test 2: Jump on hay/straw bale. Handler instructs the dog to jump on a bale and stay until released by the judge.

Test 4: Walk past farm animals Handler walks the dog on a loose lead in view of penned farm animals.

Test 8: Walk over or through unusual surfaces. The handler walks the dog over three unusual surfaces, such as a plastic targ, a sheet of plywood, and metal grating lying flat on the ground.

Test 6: Supervised separation The handler places the dog in a crate and walks out of wight for a minimum of 1 minute.

Text 7: Pass through a gate The dog stays while the handler opens the gate, passes through on the handler's cammand, and stays while the handler closes the gate.

Test 8: Handler feeds livestock The dog is tethered while the handler approaches and feeds livestock in an enclosure.

Yest 9: Reaction to another dog The diag remains stationary on a loose lead while another dag is walked by twice, about 10 feet away.

Test 10: Reaction to noise distraction The dig is exposed to two common farm sounds (such as harmsring ratio, real biowers, tractor engine, etc.) and must not panic.

Test 11: Dog approaches livestock The handler approaches pennel livestock with the dog on a loses lead. The dog may not lunge or be feasiful or aggressive to the stock.

Text 12: Physical examination The handler examines the dog for plant material or debris collected while working on the farm--examining the ears, eyes, mouth, coal, and tees.

Text items 2-11 may be conducted in a different order than lated.
